




# Main Community of Practice process




# Innovation definition

including but not limited to production, building or construction processes, a new marketing method, or a new organizational method in business practices, workplace organization or external relations *inter alia* with the purpose of helping to solve societal challenges or to support the Europe 2020 strategy for smart, sustainable and inclusive growth.


